Key Master Plan vote on July 21

CPNO is set to vote at our July 21 Members Meeting on 25 priorities drawn from the CP Master Plan.

Randy Pimsler, who chairs the Master Plan Coordinating Committee, presented the proposed priorities at the June 16 Members' Meeting, and led a discussion on the topic.

In narrowing the list from more than 100 Master Plan recommendations, the committee focused on four criteria: their importance, whether funding would be needed (and if that funding might be available once voters citywide approve a proposed \$250 million infrastructure bond referendum), whether a smaller project would lay the groundwork for other priorities,

and whether volunteers have stepped up to champion the cause.

That last criterion is crucial. Randy gave a shout out to John Skach and a whole mess of volunteers who are working on the proposed Candler Park Conservancy, and to Russell Miller, who's working to strengthen our neighborhood watch network. In addition, Coordinating Committee members Eric Dusenbury and Joseph Hacker are working on transportation issues; Cliff Mack is pushing sidewalks along, and both Randy and Seth Eisenberg are testing waters for zoning changes that the neighborhood backed as part of the Master Plan process.

Highlighting 25 of the

Time to stabilize the Messenger

Regular Messenger readers surely noticed that we skipped the last two months of publication.

Nobody wanted that to happen, and I don't want it ever to happen again. That's why I'm proposing to the board this month a new arrangement for publishing our newsletter.

Our friends in Inman Park report great success since contracting KDA Communications to handle business operations for the IP Advocator.

The KDA deal is straightforward: 1) The neighborhood continues to produce the articles and images — all the editorial content — for its own newsletter. 2) KDA handles layout, production, printing, distribution, ad sales and ad management. 3) KDA makes a lot of improvements by, for example, shifting to color and distributing by mail. 4) KDA gets all revenues but also takes on all the costs. In other words, the neighborhood neither makes nor loses money on its newsletter.

PRESIDENTIAL BRIEFING

A little over a year ago, then-Communications Officer Kate Sandhaus brought the same proposal to the board and discussed it at a Members Meeting. She noted that in recent years, the Messenger mostly has lost money. More importantly, recruiting and holding onto longterm volunteers — not only to write and edit, but also to sell ads, manage ads, keep books, layout each issue and distribute it — is a huge drain on the organization.

Last year's board decided to make another go at the Messenger for another year. If key volunteers fell into place, there was a chance to turn it into a revenue generator.

Sixteen months later, the results are in. Our Messenger expenses outran revenues in 2013 by about \$1,100. So far this year, we've actually made a little money, but that reflects one extremely rare, big ad contract that dropped into

our laps in April. Positive cash flow isn't likely to continue for the rest of the year. The more important issue is that our Messenger volunteer ranks actually are thinner now than they were a year ago: No ad salesperson, no layout or production manager, and no editor.

The good news is that we've enjoyed a significant boost in volunteers working on other projects. You'll read about a lot of that progress in this issue — from pool furniture and historic markers to neighborhood watch, sidewalks, the park conservancy and master plan implementation in general.

I'm convinced that shifting the burden of sales, production and distribution to a contractor will free up more of our volunteer energy to work on these projects and many more. And not having to worry about other duties, will reduce the grind for the editor.

Technically, this is a board decision. To ensure that folks are comfortable with idea, however, we discussed it at the June Meeting. Nobody at the meeting raised an objection. Several expressed support for the change.

If we do decide to go with KDA, it'll take two or three months to switch over. In the meantime, we'll be working really hard to ensure that we don't miss another issue.

BiRacial History Project gets \$2,800, seeks volunteers for August repairs

The Early Edgewood-Candler Park BiRacial History Project has been awarded two grants to help replace two legacy markers that were damaged over the last few months in separate incidents.

Now, it's up to Candler Parkers to chip in with a little volunteerism to install the updated signs.

Park Pride is providing a "Small Change" grant of \$1,800, and the Atlanta Mayor's Office has offered up a \$1,000 "Love Your Block" grant. The funds should cover the anticipated expenses to replace both damaged markers. To protect our investment, we're also acquiring property damage insurance with a minimum deductible on all of the History Project's Candler Park markers.

Both grants require a neighborhood volunteering component, and CPNO isn't alone in agreeing to participate. Among the others who've volunteered to help are Friends of Candler Park, the Mary Lin principal's office, the pastor at Antioch East Baptist Church, the First Existentialist Congregation Social Justice Guild, Pimsler Hoss Architects and Small Carpenters at Large.

We're hopeful community engagement will open up even more neighbors and the city to a sense of shared ownership of the markers and of our neighborhood's diverse legacy. We expect to complete installation of the replacement markers in August. If you're interested in participating in this rewarding hands-on project, please contact me at fiberandlight@earthlink.net.

Creative fundraising brings in bucks

Congrats are due to CPNO Vice President Lexa King for organizing a March cheering section that yielded \$1,500 in June. And thanks go to Candler Park Music & Arts Festival organizer Rival Entertainment for helping us with a fundraising scheme.

The Publix Marathon was at least the third run in the last couple of years where Candler Parkers proved we're loud enough to be remembered. Lexa got some 20 people to show up in ridiculous outfits early on a Sunday morning. We gave the runners a few laughs as they passed by. Last month, we learned that we'd won the first-place prize for neighborhood cheering.

Rival's Josh Antennuci agreed in May, just a week before the Music & Arts Festival, to donate a dollar to CPNO's park improvement efforts for each person who turned in a special coupon on the festival's opening Friday. We were delighted that folks turned in 480 coupons. Josh also granted CPNO a booth at the festival, which allowed volunteers to collect donations for furniture for the Candler Park pool (see article, page 5).

Small, creative fundraising efforts are one way CPNO is trying to make up for some \$20,000 in annual 420 5k revenue that the organization lost

I strongly recommend that anyone interested in Public Safety within Candler Park and our surrounding neighborhoods should join. There will be a citywide Neighborhood Watch Training module offered on July 19 from 9:00 AM - 1:00 PM. Treasurer's Report Peter Bluestone:

There was a question on last month's balance sheet regarding the unrestricted net assets amount of roughly \$93,700. Here is the explanation I received from Dave Aynes who set us up on quick books and continues to reconcile our accounts. Unrestricted Net Assets: This account measures the cumulative change in Net Income since Quick Books bookkeeping began for this entity. At the end of each year, the Net Income or Net Loss is added to the cumulative balance. We had a productive Candler Park Music festival. We sold 16 banners @\$35 each netting CPNO about \$280 (We make \$17.50 per banner and pay

a small amount to square on each transaction....) We also collected \$176 in pool donations. It also appears we collected about \$480 from the coupons used for the festival that benefited CPNO. For details of our financial position please see the attached P&L and Balance sheet [provided at meeting]

Master Plan Coordinating Committee

Joseph Hacker: The agenda primarily focused on CP priority projects for an upcoming meeting with Jay Tribby. 1. Sidewalks: Oakdale, McClendon, Candler Park Drive, Euclid Ave (but not new sidewalks). Cliff reported on discussions with the City to honor old price for repairs on McClendon. If the City honors the old price, then the cost would be shared between owner and the city. The overall price could be less but working out the shared price per owner is problematic. There are no sidewalks along Goldsboro Park (Euclid Ave). Park Pride may have some money, but it requires a match and these would be new sidewalks. September is deadline for grant cycle. Walter Brown is a player in this conversation. 2. Dekalb Ave restriping. The study has been completed, but the committee was not aware of the findings. There is concern about traffic constraints pushing traffic into the neighborhood. In other discussions: progress was reported on bylaws and master planning for Candler Park conservancy. There was consensus that this material is ready for public disclosure. There was report on incipient zoning work on the commercial CP market area. We should encourage everyone to begin thinking about the CP Fall Festival. Sponsors are needed! Packets for sponsors will be available in July. Producing a list of projects for public consumption was raised. Projects, however, are unlikely to move if they don't have owners. The Park Conservancy, sidewalks, and pool have owners, who else is ready to step forward? Gordon Rose was raised as a possible champion for the dog park. A

Visitors:

Sgt. Reith, APD, reported that crime has increased slightly compared to this time last year. Atlanta Police Department is using Nextdoor.com as a community alert/advisory tool. Neighbors are encouraged to sign up. The 311 non-emergency number will be ready for use by the end of June.

Discussion:

- The Messenger-CPNO was approached last year by KDA, a company that publishes, obtains advertisement, and distributes neighborhood newsletters. CPNO would retain editorial control. A vote will be taken next month.

June Neighborhood Planning Unit-N Report

By Amy Stout

I attended the monthly meeting of NPU-N on Thursday, June 26th as the CPNO representative.

Variances: Our agenda indicated that a variance previously requested for 535 Oakdale Rd had been withdrawn by the applicant.

Riparian Buffer Encroachment: The board voted to defer submitting any comment on an application for a riparian buffer encroachment for 600 Page Ave at the current time with the condition that the Chair follow up to get more details on the project and obtain additional clarity on the process from both the Department of Watershed Management and the Urban Design Commission. The board still has the option to vote by email to submit comments before the July 20th deadline, if it is deemed necessary. It was not entirely clear if the application were just for 600 Page Ave or if it also included 604 Page Ave.

Ordinances: The board voted to defer a vote on a recommendation for Ordinance 14-O-1240 until next month. This legislation would increase the fees for residential sidewalk installation.

Special Events: The board voted to support an application for the annual Little Five Points Halloween Festival and Parade to be held October 18, and one for the Fall Festival on Ponce to be held October 18 and 19. We deferred voting on the Candler Park Fall Fest 5K and Festival to be held September 27 and 28 (as there was no applicant present), and on the Masquerade at Krog Tunnel proposed for October 25 and 26 (as the applicant had not met with the neighborhood organization).
