The Candler Park Neighborhood Organization was called to order at 7:30 on July 14 by Maya Hahn, President. Maya mentioned one of our neighborhood businesses, "Sabrina's", which is on the corner of McClendon and Clifton and specializes in catering and carry-out. For \$6.00 or less a variety of entrees, salad and bread is available and Excellent! As a community it is important for us to support our neighborhood businesses. This concern for each other is one of the things which is unique to our neighborhood and the reason a lot of us choose to live here.

The CPNO meeting for August will be on Tuesday the 11th. Mark your calendars!

David Schenck reported on Historic Preservation. Almost 1,100 pictures of our homes have been taken to fulfill the requirements of the City to gain the designation of Historic District. Bob Craig's students at Georgia Tech have researched each and every location and are generation a sheet for each house which shows the picture and gives street name and number, land lot number, district, setback, year of construction, style, roof type, porch type, building height, primary material and primary color. A tremendous amount of effort has been expended in this project. The final document, which should be ready for presentation to City Council in late fall, will be about 1200 pages, one page for each structure and approximately 100 pages of text.

Additionally, Bob Craig brought a proposed amendment to the sidewalk ordinance which requires the utilities to replace torn-up sidewalks with the hexagon-stamped sidewalks in keeping with our neighborhood. Presently there is a technicality which has rendered the ordinance useless. A motion was unanimously carried to support the amendment and to present it to Mary Davis' office for enactment. We are attempting to do everything we can to lend a sense of continuity to the neighborhood.

Along those lines, the SPI group is continuing to meet to establish guidelines for future building in Candler Park. The main

concern here is the yet-to-be-developed Parkway land, but SPI would also help protect us from building on any lots which would interrupt the flavor of our existing homes. Unfortunately, there has been a recent incident which has brought this need to our attention with some force. A person approached CPNO a few months ago for support for a set-back variance in order to build on a narrow lot. The proposed structure is extremely incompatible with those surrounding the site. The Organization asked for modifications and would then reconsider. The person went to the NPU and got a conditional approval, (conditional on our acceptance.) He called the night before one of our meetings and asked to be placed on the agenda. He was told it was too late for that particular meeting. Instead of scheduling for another meeting, he approached the BZA (a Zoning Authority group) and told them we had refused to put him on the agenda. Based on that and the conditional approval from the NPU, he was granted the variance. A motion was carried for Michael Bishop to draft a letter to the Zoning Board to express our displeasure with the way the situation was handled and our concern for the process. Incidents like this, which threaten our property enjoyment and value, illustrate the important work of CPNO. If you are interested in participating in the SPI activity, please call Dagmar Eptsen, Chair of the group.

Michael Bishop also informed us of a woman's self-defense class which is offered by the Fulton County Sheriff's Department. It is a two-hour class free to the community. Please contact Bob Stanton if you are interested in having him coordinate a class for us.

Karen Bishop reported on the House Tour which will be in November. Two additional houses have been volunteered. Response to the poster contest has been non-existent. The competition is being kept open. Come on, all you Candler Park Artists, let's see what you can submit! Call Karen at 373-1928 if you have a poster design or would like to be involved with the tour. A \$100 framing certificate from Frabjous Frames (another one of our terrific local businesses!) is offered as a prize for the contest. Just think of the publicity you would get as the winner!




