At the June meeting of the CPNO, those attending voted overwhelmingly to support the plan that the neighborhood developed for the re-use of the Presidential Parkway land. The plan will be written up in narrative form and copies will be available for those who want them.

The next steps will be to plan for the method of disbursement for the properties that are slated to be housing, to adopt the Special Public Interest Zoning regulations that we've been working on for the past year along with the parkway plan, and to work with the city to plan the landscaping of the area which is to be parkland.

To begin planning for disbursement, we will have a meeting at the Epworth United Methodist Church, 1561 McLendon Avenue, Thursday, July 22, at 7:30 p.m. As usual, all are welcome to attend.

Speed Limits

One of the agenda topics for our June meeting was the neighborhood speed limits. As many of you know, side streets are posted at 25 m.p.h., while the more heavily traveled thoroughfares are 30 m.p.h..


As many of you also know, it appears a problem with individuals speeding throughout our area is on the increase. With this in mind, several individuals have volunteered to seek ways in which we can work with the City of Atlanta's Bureau of Traffic Engineering and the Police Department to curtail the situation. Hopefully, we'll find some creative solutions as to how we can bolster speed limit observation levels among non-residents as they travel through Candler Park.

Although this should address the problem on main streets such as Clifton, Oakdale and McLendon, we can't realistically expect the government agencies to focus much attention on the side streets. As discussed at the monthly meeting, there was strong feeling that vehicles speeding on side streets were those of Candler Park residents. So in this sense, as a resident of the area, please make the effort to observe your street's, and your neighbor's street's, posted speed

limit. If you're a landlord, please make sure your tenants are aware of this request.




