Candler Park Co-op Update

In March of 1993, Candler Park Apartments became the Candler Park Cooperative (CPC). In 1994, CPC underwent the first phase of remodeling in order to bring its 56 units up to city housing code. During this period, time was of the essence. It was very hectic and confusing. That year certainly proved to be a very trying year, but it also proved to be what some people typically call growing pains.

CPC is essentially a business. In many ways, it's like any other business but it is a very different and unique concept. One example is that the CPC belongs to the people who use it or, in other words, to the residents within it. The residents have organized to provide themselves with the goods and services needed to sustain a comfortable yet affordable living environment.

The members at CPC invest in shares in the cooperative to provide capital for a strong and efficient operation. Many of the cooperative bills are much like what typical homeowners pay, for example, mortgage, taxes, etc. After all bills have been paid, the remaining revenue is reinvested into the operation of the cooperative much like how one does for their home or business. CPC only charges what is necessary to operate the cooperative efficiently and effectively.

The members/owners at CPC share equally in the control of the cooperative through a democratic process. Members nominate candidates from the residents to serve on the Board of Directors. At CPC, the Board of Directors primary role is to see that the cooperative runs efficiently both physically and financially. Typically, the nominee must demonstrate the desire to serve and an understanding that with the position comes great responsibility. Being a board member is strictly voluntary. The Board of Directors meets at regular intervals to discuss everything from reports from management to interviewing prospective members. CPC's directors are also charged with the important task of hiring management to handle the day to day affairs. In February of 1995, the CPC Board of Directors did just that. After many hours of deliberation we acquired the services of G&M Management Corporation. G&M was founded by Mr. Alex Miller. Mr. Miller and his company bring over 20 years of experience with managing and training cooperative housing associations. Within the first week, positive changes could be seen. We are very pleased with their service.


This year, the pace seems to be more conducive to living and learning the cooperative spirit. CPC members are as diverse as the community at large. CPC's melting pot consists of single parent

families, two parent families, gays and lesbians and a wide range of racially and culturally rich people. Professions include teachers, students, artists, office workers, self-employed entrepreneurs and counselors. Cats, dogs and hamsters reside at CPC as well. There are lots of exciting things going on at CPC. Recently, we were informed of approved funding for the second phase of renovation. Improving the outer appearance of the cooperative has been a concern for the residents. We are working to amend this situation.

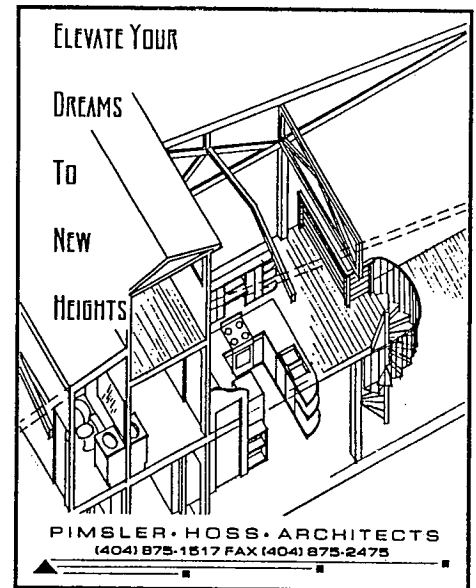
