## **Public Safety Report**

For the latest four week period, there were three motor vehicle thefts, nine thefts from vehicles, 11 damage to vehicle reports and 12 burglaries. This is a big increase in damage to vehicles and burglaries compared to the previous period. In one night alone (August 6-7), there were seven incidents. This is in spite of the good news that on August 6, Dwayne Brooks, a suspect in many thefts, was caught and arrested based on the efforts of the alert staff at the Candler Park golf course.

In addition to the 50 incidents in our neighborhood reported below, I call your attention to a homicide which took place around the end of July at Davis Plaza in Little Five Points, just outside of our neighborhood boundary. A 16 year old hit a 20 year old, who was drunk, and the 20 year old hit his head on the pavement, resulting in his death a few days later. Inspector Hughley from Zone 6 researched the case for me; he says that the suspect is not necessarily tied to the "Bubble Gum Gang." (Thanks to a Candler Street neighbor for inquiring about a rumor he heard - homicides are not in the Beat Book.) There have also been recent reports of mail theft in Lake Claire. A middle aged woman and a younger woman claimed they were delivering pizza flyers as they systematically removed mail from boxes.

Thanks to all who came out and joined us in the park for "National Night Out" against crime. It was fun. Please let me know about any crimes I miss so I can report them in an update the next month. And do call me at 378-5883 after you make a police report so I will know about it before I go to the precinct. Please get in touch if you are interested in working together to make our neighborhood a safer place. Between Messenger reports, check the CPNO number (770-453-8255) for updates on crime. 


## Sign, Sign, Everywhere a Sign!

A recent article in the CITYLIFE section of the *Atlanta Journal/Constitution* regarding yard sales included some misinformation with respect to the posting of signs. The article stated that the City of Atlanta would not fine people for posting signs, only for not removing signs after the sale. But, according to the City's sign ordinance, it is prohibited to affix 'signage on sidewalks, crosswalks, curbs, street lamp posts, hydrants, traffic signal control boxes, utility poles, trees or other structures located within the public right-of-way. Violators will be held accountable and will be fined for each individual sign. With a fine of up to \$1,000 per sign, or the possibility of 2 months imprisonment, violators may also be expected to work on public streets or on public works of the city.' Major Banda, of the Atlanta Police Department, recently agreed to step-up enforcement of the sign ordinance in Candler Park so please be aware of the possible consequences before you post any signs.


