## Public Safety

In the latest four week period, there were five motor vehicle thefts, six thefts from vehicles, six damage to vehicle reports, six burglaries, two other thefts and one armed robbery. This ends the relatively high number of burglaries and thefts from vehicles seen in the past three months. A report to police that men were looking into cars on Goldsboro Road led to the arrest of the driver of a stolen vehicle, but unfortunately not until he had wrecked it. Officers arrested two residents of the 1300 block of McLendon for selling marijuana, and found five ounces of marijuana, a half gram of heroin, four handguns, a "37 mm launcher" and ninja weapons after a search.

During the holidays, be sure to take cell phones and other items from your car, as usual, and don't leave things lying around your house or garage. If you are going out of town, leave lights on a timer and let your neighbors know, cancel the newspaper and have mail stopped or picked up. You can also request a special police patrol.

Please let me know about any crimes I miss so I can report them in an update the next month. And do call me at 378-5883 after you make a police report so I will know to check for it before I go to the precinct. ## SPI Update

I apologize to anyone who came to the November CPNO meeting for an update on the Candler Park Special Public Interest (SPI) Zoning. Believe it or not, I got dates mixed up and did not attend. Since there is no meeting in December, I will be making a presentation on the SPI at the January meeting of CPNO. In the mean time, I

would like to give an overview of how land will be disposed and what type of housing will be placed in each area.

The land running along the south side of North Avenue from Moreland to Candler Park Drive is in the process of becoming parkland. The park will stretch south from North Avenue to Druid Place and then continue eastward along existing property lines. The lot on the northeast corner of North Avenue and Moreland and a strip of land along Moreland Avenue between Mansfield and Druid Place will also be park. The park will be a passive use park with no playgrounds, athletic fields, or pavilions.

Land running along the north side of North Avenue, land east of the golf course between Terrace and Page, and land along the south side of Druid Place (except for the first 200 feet east of Moreland) will be zoned for single family development.

Land along Moreland Avenue between Mansfield and Druid Place, extending from the strip of park to a point approximately 200 feet east of Moreland Avenue, will be zoned for duplex density development.

The D.O.T. will not dispose of property until the SPI has been approved by the Atlanta City Council. Complete takings will first be offered back to former owners while partial takings will be offered back to existing owners. Once the SPI is approved, the D.O.T. will use a sealed bid process to auction off the remaining land. Land disposition will be staggered to prevent someone from acquiring a large chunk of land at one time.

Please note that the SPI only affects land that was condemned by the D.O.T. It does not affect existing housing that borders the park. The SPI was developed by a subcommittee of CPNO and has already been approved by the neighborhood. The document has been submitted to the City and is being reviewed by the City's legal department. 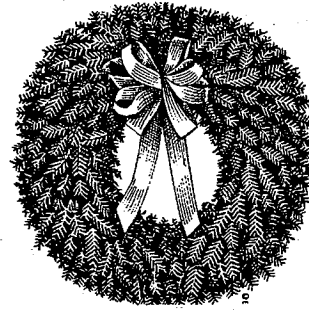

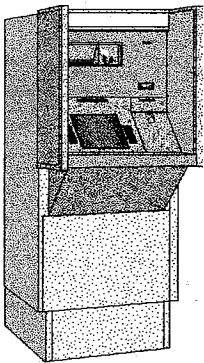
