Property Tax Struggle Enters Final Stage

We are in the final stage of our long effort to secure equal taxation with the rest of Atlanta. Through the combined efforts of all the neighborhoods in Atlanta/DeKalb and the political leadership of Councilmember Cathy Woolard, the city enacted an ordinance to provide refunds of overpaid property for tax year 2000. This was in addition to the refund ordinance for 1999.

These ordinances were necessary because our homes are assessed for property tax purposes by DeKalb, while the rest of Atlanta has its homes assessed by Fulton County. Differences in assessment practice between the two counties have led to inequality in taxation within Atlanta.

For example, in 2000, the assessments on property in Atlanta/DeKalb rose an average of 32.9% while assessments in Atlanta/Fulton only increased 3.7%. Meanwhile, studies of sales data show that property values have been rising at about an equal rate in both parts of the city. Since we pay the same millage rate and receive the same services as the rest of Atlanta, we believe we should also have our homes assessed on an equal basis.

As obvious as this might seem to us, others disagree. The Atlanta Board of Education has sued to overturn the 1999 refund ordinance. Also, believing we should not have refunds of taxes if they do not, a group called Fulton County Taxpayers Association has sued to overturn the 2000 ordinance.

With vigorous citizen action, we have achieved more than anyone thought possible: the enactment of ordinances for repayment of overcollected taxes for both

1999 and 2000. These days, though, it seems no political action is finished until the issue is heard in court.

We have fought for fairness and equality for our neighborhood for over a year. The city was uninterested in correcting the problem. Only by our efforts were these ordinances enacted. Since the ordinances are now law, the city should

defend them against the lawsuits. Remember, though, the city administration fought against them all along. Now that the ordinances are law in spite of their efforts to prevent their enactment, the city is making minimal effort to defend them.

It falls to us — as it has all along — to correct the problem. We have to raise enough money to defend the ordinances ourselves.

We have worked with attorney Mary Carole Cooney during this entire process, so she knows the issue extremely well and has done all the preliminary legal research necessary to go to court. However, this last phase will of course require more intense legal work than anything we have done previously.

We need to raise about \$5,000 - \$10,000 to finish what we started over a year ago. These funds, of course, would come from all of Atlanta/DeKalb, not just Candler Park residents.

Setting the exact amount each person should contribute is impossible, but since many people have asked what is fair to give, here is a suggestion: \$75-150 from each household in Candler Park, depending on your circumstances. Remember that the average refund is about \$1,200 for each year, so this is a small amount to invest compared to the potential return.

However, for many of us, this not about how much refund we might gain. It is about how Atlanta treats its citizens and conducts its business. It is about fairness and equal

treatment. And maybe it is a bit about having Atlanta remember that even though we in Candler Park are few in number and exist on the periphery of Atlanta, we should not be ignored when decisions that affect us are made.

One would have hoped that the city would have remembered that this was the same feisty neighborhood that fought a proposed highway to a standstill. It seems that every 10 or 15 years the powers that be have to be reminded that this is a neighborhood that can take care of itself.

Update On Property Tax 1999 Refunds

When The Fulton County Taxpayers Association sued to stop the refunds of 2000 taxes, they also obtained a restraining order against sending any 2000 refunds until the lawsuit is resolved. The City Law Department then voluntarily stopped the 1999 refunds, even though neither FCTA nor the School Board asked them to do so.

This action is unfortunately typical of a Law Department that fought these ordinances for more than a year and, now that they are law, is doing little to uphold them. We believe freezing 1999 refunds is particularly unfair considering the city has yet to issue refunds for many requests submitted to them five and six months ago. We are attempting to get the Law Department to rescind its order.

In contrast to the Law Department, the Clerk's Office is doing what it can. The Clerk's Office has agreed to continue to mail refund forms to those who request them, and the Finance Department will continue to process the forms short of actually mailing the check. Thus, if the order is lifted, or when we win the lawsuit, the checks can go out immediately. The Clerk's Office has also apologized for how confusing the refund form is.

The refunds have been on again, off again in the past. We would advise people to continue to send in the refund forms. If and when refunds are restarted, there will be a large backlog of checks to be sent out and that will likely take priority over processing new refund forms at that time. If you go

ahead and send in your refund form now, you will be at the head of the line.

Two questions some have asked: if you paid all or part of the 1999 taxes, you CAN apply for a refund even if you did not own your home in 1998. You would need to obtain a copy of the 1998 bill and proof of its payment from Fulton County. Also, under the DeKalb section of the refund form is a row entitled "Atlanta General." This is the same as "ATL OPNS" on your 1999 Atlanta-DeKalb tax bill.

Since a guide to filling out the refund form was published in the Messenger in September, it will not be reprinted in full here. Two changes, though: to obtain a copy of the refund form or for help filling out the form, call Forest Webb in the City Clerk's Office at 404-330-6031. Do not ask for anyone else. You will probably just get incorrect information. If you do still do not get satisfaction, Paula Ward here in Candler Park has volunteered to field questions. You can contact her at 404-524-8876, or e-mail her at paward@us.ibm.com. You can also download a copy of the refund form and look at a copy of the instruction sheet from the Candler Park website at www.candlerpark.org.

Remember, though, if we do not get enough donations to continue our legal defense of the ordinance, we will not be getting any refunds. Please consider a donation.
