## City to CPNO – Amend Your Bylaws !

Steve Cover, the Commissioner of the Dept of Planning and Community Development, notified all NPU Chairs May 2 that the City of Atlanta's Law Department had ruled: **"The City Code does not allow an NPU or constituent organizations to restrict a resident's ability to vote on matters concerning his/her NPU by requiring payment of a membership fee in order to exercise the right to vote.** Any NPU or any constituent organization that exercises representative voting on behalf of residents is precluded from requiring residents to pay fees in order to cast a vote."

Because NPU-N has a representative structure and only a single agent from each constituent organization is empowered to vote, the NPU-N Chair has instructed NPU-N's constituent organizations to review and revise their bylaws in order to comply with these instructions. The current bylaws of the CPNO do not comply.

While some debate whether the City Code truly addresses this issue, the intent of the legislation that established the NPU system is clear: to promote citizen participation in neighborhood planning by creating a formal structure for residents to provide input.

What does this mean for CPNO? First and foremost, it means that the neighborhood organization's bylaws must be amended for 2007 or NPU-N's authority to make recommendations on planning issues will likely be jeopardized. The Board expects to have draft

revisions to the bylaws ready by the August CPNO meeting, and members will be notified in advance of the proposed changes and of the date of the vote.

How will this affect CPNO voting procedures? That depends ultimately on how the organization's membership decides to amend the bylaws. Importantly, the City of Atlanta's Law Department ruling is specifically limited to matters concerning the NPU. That means, for example, that the ruling does **not** prevent CPNO from allowing only dues-paying members to vote on non-NPU matters (such as deciding how CPNO funds will be spent or electing officers other than the NPU Representative). The ruling also does not forbid CPNO from charging dues to be a member of the neighborhood organization, provided membership is not a requirement for voting on NPU matters.

Until the bylaws are revised, it seems appropriate to allow all Candler Park residents to vote in situations where our NPU representative is being instructed to take a position to NPU-N (such as rezonings and variances). This change should be easy to implement since the CPNO adopted a special rule of order in February, 2006 authorizing nonmembers who are otherwise eligible for membership in the neighborhood organization to make motions, speak in debate, and vote in meetings of the "committee of the whole."



# Clifton Sanctuary Ministries Returning to Lake Claire – Thank You Candler Park!

It was simply hardship compounding hardship when fire gutted the principal office and group residential space of Clifton Sanctuaries Ministries in Lake Claire, 9 months ago. This program had existed in our adjoining neighborhood for nearly 25 years, with the endorsement of the Lake Claire neighborhood organization, going nearly unnoticed by those of us living west of Clifton Road. This faith-based program is an extension of the Presbyterian Church and utilized the building and land still owned by the denomination.

However, fate stepped in late last summer in the form of a devastating fire to provide Candler Park an opportunity to show how open our arms can be.

The program at Clifton Sanctuary Ministries lives on today and continues to strictly be one of assisted housing and live-work. The thirty men rotate into the program after specific referral by other agencies (especially the VA) and careful screening prior to enrollment. These men are a sector of our working class, each one having employment during the day and returning to the program in the evening for their meal and housing. They all have ambition of finding a solution to their difficult situation and move onto more permanent housing arrangements and full-time work within a matter of a few months. Make no mistake – this is NOT a homeless shelter; and while the in-town communities certainly have a homeless problem, this is definitely one of the solutions.

The fire last summer that destroyed their building brought the Clifton Sanctuary Ministries program to find temporary quarters at Epworth United Methodist Church across from Candler Park. This was no means an ideal temporary solution, but Epworth believed that the compassion for these men and the program would provide the means to accommodate their hardship. Epworth hardly had the physical

space to take in the program, and could not undertake renovations for showers, laundry, and kitchen needs. Furthermore, at the time Epworth was providing space for a vibrant after-school program whose needs were also a matter of great concern. Although arrangements to accommodate both programs were in the works, Epworth took in the men's program and the director of the after-school program decided to halt operations. With every difficult decision comes an equally difficult consequence.

The presence of the men at Epworth has enriched the church life and the diversity of the surrounding neighborhood. The men regularly join in Sunday church service and several have joined the church. An additional Wednesday night Bible Study was initiated to offer a venue for the insights of men who are fresh from counseling (in touch with themselves and their spirituality), full of life experience, and well-versed in current events. The church has also benefited from the talents of skilled workers, painters, chefs, and singers. No instances of crime in or around the church have occurred due to the presence of this program; in fact, participants have protected the church from break-ins, vandalism, and trespassing on several occasions.

This story has a happy ending. The Presbyterian Church has decided to maintain the original Lake Claire location as the headquarters for the Clifton Sanctuary Ministries. The building is undergoing repair and renovation and it is now anticipated that the program and the men will return to more comfortable arrangements by mid-summer. While their presence will be missed, the friendships and relationships between this program and our neighborhood will persist. As good neighbors, Candler Park has again reached deep to provide and accommodate those in need – that's what makes Candler Park great!

# Minutes of the May 15, 2006 CPNO Meeting

Meeting was started but not officially called to order due to lack of a quorum. Announcements: CPNO now has over 200 members. 200<sup>th</sup> member to join received a \$20 gift certificate for The Flying Biscuit.

NPU-N Report by Amy Stout: Citizens can go to [www.beltlinecommunity.org](http://www.beltlinecommunity.org) to fill out surveys as part of phase one of community input on the future BeltLine. City hosted a public forum on May 6<sup>th</sup> for the sole purpose of allowing citizen input on the proposed zoning ordinance overhaul (see Pg. 7 for details on how to submit feedback). At its May meeting, NPU-N voted: 1) to support a substitute ordinance by Councilmember Anne Fauver that would allow for participation of a wider area of neighbors when petitions for traffic calming devices are submitted; 2) to oppose a substitute ordinance by Councilmember Natalyn Archibong that would require the posting of demolition permits for residential structures, because NPU-N deemed it meaningless in not providing a means to appeal or stop a demolition; 3) to approve a liquor license application for the new Pacific Kitchen restaurant moving into the former Lush site; and 4) to approve a request to reduce

## If It's A Crime Call The Police First

People often report to me incidents that happen to them through direct e-mail or cpsafetylist. Other times folks tell me about something that happened to a neighbor or just about a crime they heard about.

I try to confirm these reports by calling zone 6 precinct, checking the crime reports I receive from zone 6, or simply asking one of our beat officers about the report.

Most of the time these reports cannot be verified. I am sure many of these incidents are true, but some are just rumors.

The most important action we can do to ensure that a crime is reported is to call 911. The police department cannot investigate a crime unless it is told about it.

I know it's frustrating to go through the process of reporting a crime. But, if the police department is not informed of a crime, for their purposes and ours, that crime didn't happen.



# Minutes of the May 15, 2006 CPNO Meeting

(continued from preceding page)

Zoning Committee member Tom Painter strongly encouraged neighbors to let the City know their views on infill regulations and the zoning ordinance, in light of the proposed overhaul.

The meeting was called to order at ~7:20 PM, when a quorum was obtained. The proposed agenda was adopted, and the minutes from the previous meeting were approved.

CPNO approved a motion stating that it had no amendments to offer NPU-N regarding NPU-N bylaws as preparation for the upcoming annual vote to approve or reject the representative voting structure of the NPU.

There was a motion and a second to

approve the proposed CPNO bylaws change that would redefine the authority of the Zoning Committee. There was concern that while proper notice of the motion had been provided, separate notice of the meeting had not. The motion was withdrawn.

Officer Davidson from the APD reminded residents to always call 911 with a problem.

CPNO voted to authorize payment of \$475 to Epworth Church to cover rental of meeting space for January 1 through June 1.

## Update on Candler Park Brook – Major Construction is Underway!

Walt Ray of Park Pride updated the Candler Park Brook project steering committee and all neighborhood stakeholders on construction progress for the week ending May 23<sup>rd</sup>.

Walt reported that the Contractor (Heavy Constructors) started to add stone to the stream channel between the site of the detention pond and the existing concrete flume. Pipes were laid near the playground. The trench by the swimming pool parking lot was filled with concrete. Parking should be back to normal.

Walt also advised that upcoming activities will include the Contractor closing the playground, pavilions and cul-de-sac for a period ending June 15<sup>th</sup> to ensure the safety of all park patrons and workers during construction of a very deep drainage pipe between the cul-de-sac/parking area, playground/pavilion area and the tennis courts. Everyone should take precautions and avoid crossing any area marked by orange fencing or entering the construction zone.

## NPU Report – May 22 Meeting

The NPU-N board voted to defer consideration of application V-06-127 by Susan Renno of **613 Terrace Ave NE** seeking a variance to increase the maximum lot coverage to 53.2% to allow for an addition to an existing driveway. Applicant had not yet met with the CPNO zoning committee, nor presented to CPNO membership for approval.

Representatives from Southeast Capital Partners, Inc., the company redeveloping the former **Excelsior Mill**/current **Masquerade** site, made a presentation. They have now acquired adjacent property from Wayne Mason's NE Atlanta BeltLine group and are revising their plans for the development at 695 North Avenue in NPU-M. They are proposing to adhere to all the stipulations previously agreed to when this property was rezoned from I-1 (Light Industrial) to MRC-3C (Mixed Residential Commercial with Conditions) in December 2005, except for one (minimum porches of 6 ft depth and 8 ft width).

According to the new plan, the combined property would be rezoned PD-MU (Planned Development - Mixed Use), and the additional acreage would allow creation of 125 additional parking spaces, which the developers feel is critical to making the converted mill building viable for commercial use (tentative plans call for a restaurant tenant and perhaps others). The NPU-N board voted to support the application, although technically only NPU-M's input is required. In the near future, legislation transferring the development rights to the Mason NE BeltLine group (for the portion of the property that will be preserved with landmark status) will be considered by Atlanta City Council.

Attorney Hakim Hilliard of McKenna Long & Aldridge and planner Alycen Whiddon of HDR appeared on behalf of NE Atlanta BeltLine group to show their redevelopment plans for the two parcels of BeltLine property located within NPU-N. The developers have submitted applications requesting rezoning from I-1 and I-2 (Industrial) to MRC-3C to allow small commercial uses on the ground floor. Two nodes of development are proposed for Parcel 4, located in **Poncey-Highland** and Old Fourth Ward. Plans for Site 1 in Parcel 4 (bounded north by North Avenue) call for four buildings of 8, 15, 15, and 12 stories respectively, with a total of 757 units. This site, to be located east of the proposed transit line, could be accessed via Angier Springs Rd (the dead end road that terminates at Barking Hound Lounge). The plans for Site 2 in Parcel 4 (bounded north by Ralph McGill Blvd, and south by Freedom Parkway where East Freedom Parkway splits off) include two 5-story buildings of 70 units each that would

be accessed via Ensley St. These would be across the tracks from Freedom Lofts. The only proposed development for Parcel 5 (located in **Inman Park** and bounded north by Freedom Parkway and south by Highland Ave) would be a 4-unit, 3-story townhouse development located on the opposite side of the tracks near redevelopment taking place at the former Mead Paper site.

The City of Atlanta is updating its **maps of neighborhood boundaries** in preparation for development of official electronic maps. This may be of importance to residents on the north side of North Avenue, and the east side of Clifton Road. While CPNO's bylaws recognize these citizens as Candler Park residents, the City considers the center line of these roads as the dividing line between neighborhoods. Hence, according to City officials, these residents live in Druid Hills and Lake Claire, respectively. Our neighborhood may wish to request changes to the map, though no procedure for this has yet been announced.
